Section 5(1) (a) Application Area

The area is considered appropriate for designation as a neighbourhood area for the following reason:

The Parish is long established, well recognised and clearly defined area entirely within the remit of the Middleton Cheney Parish Council. Within the parish, the great majority of residents live in one nuclear settlement, which has a clear physical and social identity. The Parish is a democratically elected body representing the entire local community within the parish and is committed to ensuring that future planning decisions within this area reflect that community's wishes.

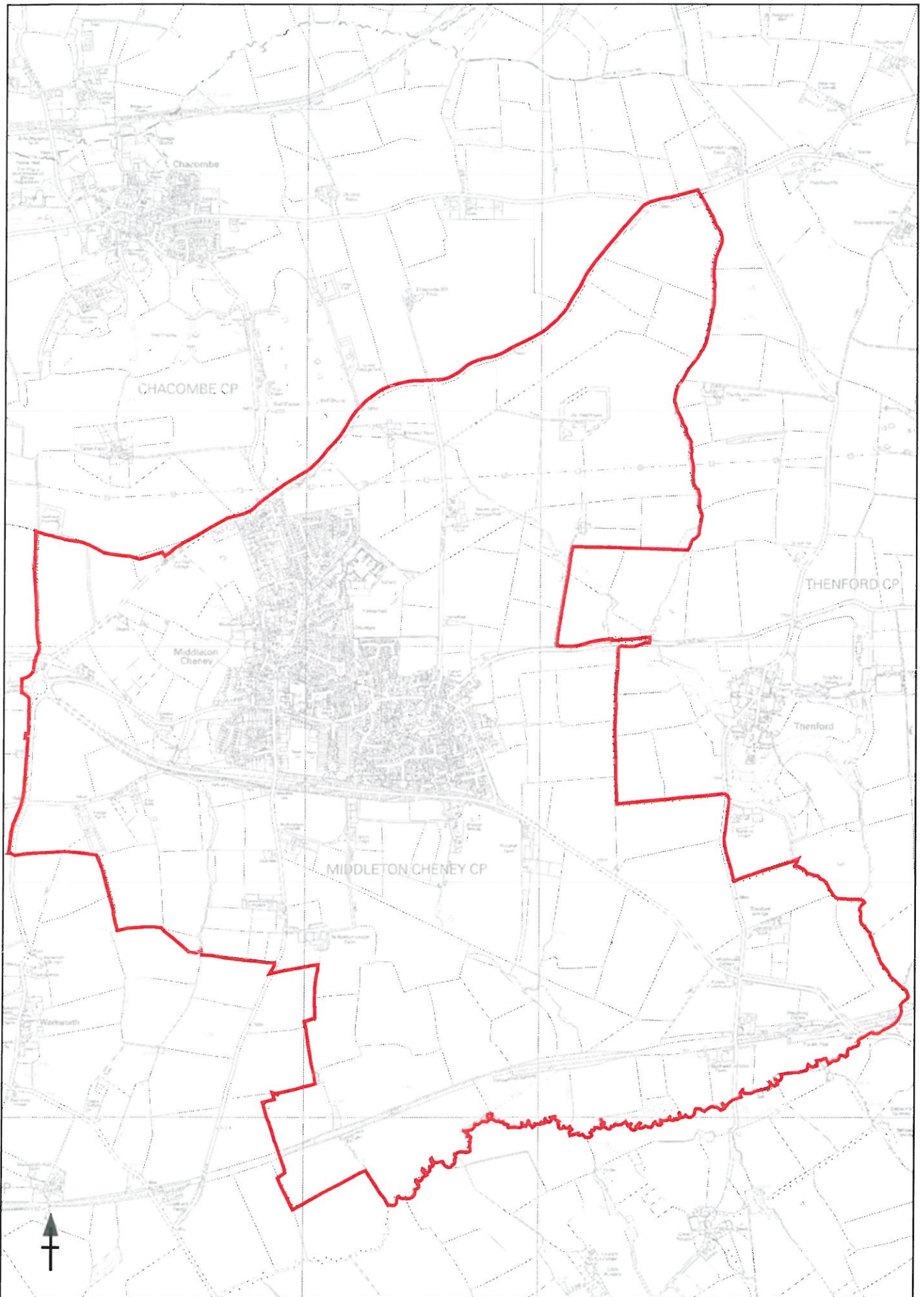
